## CONTRACT APPENDIX

### 2017 MISS SEVEN RIVERS OF WISCONSIN/MISS AMERICA SCHOLARSHIP FUND – SCHOLARSHIP RULES AND REGULATIONS

THE MISS AMERICA SCHOLARSHIP FUND THROUGH THE MISS SEVEN RIVERS ORGANIZATION OF WISCONSIN WILL AWARD SCHOLARSHIPS UNDER THE FOLLOWING CIRCUMSTANCES:

1) ALL FOLLOWING CONDITIONS ARE MET BY MISS SEVEN RIVERS 2017:

- a.) Miss Seven Rivers 2017 will attend all appearances scheduled by the Miss Seven Rivers Organization. Many appearances will be scheduled prior to July 1, 2017. All appearances made by Miss Seven Rivers 2017 must be approved by the Executive Director.
- b.) Miss Seven Rivers 2017 will write Thank You notes to all specified sponsors. She will be provided with postage for said sponsor letters. Additional postage will be the responsibility of Miss Seven Rivers. She will receive 50 official Miss Seven Rivers stationery with envelopes. Any additional stationery must be requested through the Executive Director.
- c.) Miss Seven Rivers 2017 will be given the option to attend the Miss Wisconsin Preview Night for Western Wisconsin titleholders (typically a Tuesday or Wednesday in early June). Once she has committed, the decision will stand and she is expected to adhere to the decision. ALL wardrobe for the Miss Wisconsin Pageant will be worn at the Miss Wisconsin Preview Night.
- d.) Miss Seven Rivers 2017 will attend all scheduled appearances and competitions for Miss Wisconsin Prep Day (a Saturday in April) and Miss Wisconsin 2017 (a full week in June).
- e.) Miss Seven Rivers 2017 will attend and fulfill obligations, which will include but not limited to: emcee, performer, and co-organizer of the Princess Program, at the Miss Seven Rivers Pageant 2018.
- f.) Consent is given for personal and professional photographs, including all contestants, the Miss Seven Rivers Pageant, and/or Miss Seven Rivers 2017 to appear on the Miss Seven Rivers website and other publications.
- g.) No contestant shall cancel her participation within 2 weeks of Miss Seven Rivers 2017 after submitting a signed and notarized contract or contract appendix. If a cancellation occurs, the Miss Seven Rivers' Executive Director will be the final decider on whether to accept said contestant for future participation as in any pageant occurring in the year 2018 or later.

h.) If you are competing for any pageants **before** the Miss Seven Rivers Pageant, you must make the Executive Director aware. If you win a title before Miss Seven Rivers, your spot will be given to the next person on the waiting list and your contract will be considered null and void.

2) ALL OTHER RULES ARE FULFILLED:

a.) Wardrobe for the 2017 Miss Wisconsin Pageant must be approved by the Miss Seven Rivers Organization no later than June 1, 2017. There is no wardrobe allowance and wardrobe attire is the sole responsibility of the contestant.

b.) Official Miss America Local crown must be returned to the Miss Seven Rivers Organization no later than January 1, 2018. If the crown is not returned by said date, the Miss Seven Rivers Organization reserves the right to charge a \$150 crown fee to titleholder. Please consult with the Miss Seven Rivers Organization if the crown would like to be purchased for personal usage.

c.) Official Miss America Local sash is a gift to Miss Seven Rivers 2017 by the Miss Seven Rivers Organization.

d.) Name of the college, university or other accredited institution will be provided to the Miss Seven Rivers Organization when requested. All scholarship money will be presented the week preceding the Miss Seven Rivers Pageant in 2018.

3) SCHOLARSHIP USAGE:

Scholarship funds may be applied to tuition, textbooks, supplies, academic fees and other appropriate educational expenses. All unusual or questionable items of expense must be referred to the Miss Seven Rivers Organization with as much information as possible and far enough in advance for consideration of approval. Amounts received as scholarship payments are taxable income to the extent that they exceed "Qualified Tuition and Related Expenses".

Qualified Tuition and Related Expenses include tuition and fees required for enrollment or attendance of a student at an educational organization, including fees, books, supplies and equipment required of all students in the particular course of instruction.

Payment of all approved expenditures will be made directly to the college, university or other accredited institution unless extenuating circumstances exist. In such cases a letter of explanation accompanied by paid receipts and/or copies of canceled checks will be required which qualify the expense for reimbursement to the payer or scholarship contestant.

Contestants receiving scholarships at the state level must use the scholarship won at the local level prior to applying for funds at the state level. Verification must be submitted in writing from the Local Director that all local scholarship funds have been exhausted.

I have read and understand the above statements. By signing the Contract Appendix, I understand I will fulfill the obligations of Miss Seven Rivers 2017. If I do not fulfill said obligations, I will forfeit my local title, local scholarship, and state scholarship(s).
